Board of Directors:

by Don Nuss RHA Secretary From the July 10 RHA Board Meeting:

-- The Board is tracking the impact of the new (more expensive) Townhome trash contract on the budget.

-- Townhome drainage: the Board is considering its next steps based on the report provided by the Northern Virginia Soil and Water Conservation District.

--Resident Rules and Policies handbook update: The Board has located a digitized version of the most recent handbook to use as a basis for an update.

-- Fire Lane/Parking Space/Reserved Parking Space marking: Battlefield has agreed to provide labor if RHA provides paint, but would charge for updating numbers. Property Manager (PM) Games, bounce house, water slide, suggested waiting until after sealcoating is done (as part of the reserve study).

> -- Compliance Inspections: PM agrees compliance inspections should begin as soon as possible.

Recreation Committee, Inc. (RCI): by Gene Harper, RCI Treasurer

For the first time since the pandemic started in 2020, the committee met both in-person and online on July 12 with seven members present, along with Sequoia Senior Community Manager Dale Edwards. Five attended via Zoom. Two, along with a community resident, were in-person in the poolhouse community room.

Committee member Colleen Ward, who has previously served as secretary for both RCI and Reflection Homes Association, has volunteered to fill the vacant RCI secretary position for the rest of the year.

The committee decided to have pool guards start using a hand tally people counter, also known as a clicker, to gauge how many community residents are entering pool facilities daily.

During a June inspection of pool operations, a Fairfax County stormwater investigator observed chlorine pool water backwashing directly into the creek beside the pool. The official wrote corrective action had to take place in part to "ensure all pool water that is discharged is dechlorinated and tested before draining." The pool company contract staff took needed, quick steps to rectify the situation. A follow-up inspection in early July found the RCI pool to be in compliance, with no chlorinated water being discharged into the creek. Government agencies take water contamination very seriously. The small tributary that wends its way through our community empties into Horsepen Creek, which flows into Broad Run, which empties into the Potomac River, the main water source for drinking water for the whole DMV metro area.

RCI members also agreed to move closer to meaningful actions that will slow erosion of the lands around our creek through measures such as replacing trees and other vegetation. For example, the committee has begun alignment with the Northern Virginia Soil & Water Conservation District and is seeking grant funding from the Virginia Conservation Assistance Program.

The committee began its final assessment process to deliver a revised poolhouse rental agreement. One committee member likened this end-process to using a fine-tooth comb.

Ongoing discussions continue toward improvements to increase camera security throughout the RCI area.

The meeting was adjourned at 9:17 p.m. The next meeting date is set for August 9 at 7 p.m.

On July 17, Sequoia Management issued a notice of contract termination to RCI, effective Sept. 30, 2023. No reason was given for the action. The committee has set into motion plans for a seamless transition to a new contractor. Look for



RHA and LHA Celebrate National Night Out 2023! by Gene Harper, RCI Treasurer





Everybody was talking about how nice the weather was on the Aug. 1 annual National Night Out in the pool parking lot. Temperatures were just right – not too hot or cool. July's hot, hot sun hid behind that pesky, highaltitude film of Canadian wildfire smoke. And the slight, humidity-free breeze felt more like early fall than mid-summer.

Everybody seemed to agree, including chief organizer Georgette Nuss, who added she felt so good and so happy to be out and about again after recovering from major illnesses earlier in 2023. For her, this community gathering was just what the doctor ordered.

"We figure at least 150 people filled the lot," she estimated, about half again larger than 2022's 100 attendees. Adults sat, stood and



watched or followed their children around as they tossed, jumped and bounced their way through the evening. Among thrills to fit these movements were the Bounce House, the Slide N Splash and the bean bag toss. And the long lines and wait for snow

cones and popcorn didn't discourage anyone. Adults handing out these treats estimated some 400 snow cones and 350 bags of popcorn were devoured during the two-hour evening.

One main reason behind National Night Out played a very minor role in 2023: In previous years there were multiple police members and their cruisers and motorcycled officers showing off their machines and equipment from the Reston District precinct that patrols our community. But this year only two police cruisers and three officers were able to come. Still, mothers insisted that their kids pose for pictures side-by-side with Fairfax's finest.

One young teen asked Officer J.A. Jones to handcuff him for his friend to photograph. "I can't do that, guys," Jones protested, adding, "It wouldn't look good for community relations." So instead, he sent them over to Sgt. Michelle Pastora to see if she would let them take a picture sitting behind the wheel of her Ford sedan police cruiser. They seemed less impressed, but still glad for the opportunity.

"It's always good to see kids and for them to be comfortable seeing us," Jones said. "People in this area are good to us."

Another kid walked up to Pastora to ask her to sound off the cruiser's siren. She said that would be too loud but assured him the sedan's blue-flashing lights are an equal attentiongetter. She followed up by giving the youngster an FCPDemblazoned stringed bag emptied of hats and miniature footballs handed out. Bag in hand, the young, satisfied customer skipped away, smiling to show off his present to his awaiting family.

The resident running the Slide N Splash water attraction admitted she had "so much fun [as] a willing sacrifice for the big kids to splash" her. It was a "fun, fun night," Patsy Velin noted. That pretty much summed up the community's feeling about 2023's Night Out.
